

All workshops and Lunch & Learns offered by the United Way of Peterborough & District are held at the Lions Community Centre, 347 Burnham Street, Peterborough. It is an accessible building with a wheelchair accessible lift.

Some of our sessions are held in the Lions Den room located on the lower floor of the Centre. It is accessible through the rear entrance of the Lions Community Centre from the parking lot. A key is required to operate the lift so please advise us in advance if you will require the lift and if possible arrive a bit early.

The Fair Workplaces, Better Jobs Act, commonly referred to as Bill 148, received Royal Assent on November 27. This provincial legislation brings several significant changes to the provincial Employment Standards Act and the Ontario Labour Relations Act. So, what do these changes mean for your organization?
